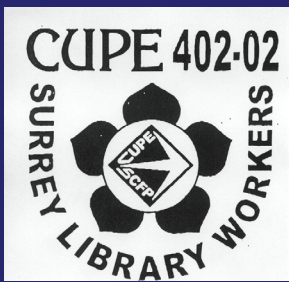

Vacation Leave for Regular Staff

April 1 is quickly approaching so we are thinking about our vacation leaves. Where shall I go? What would the family like to do? or maybe your best friend's wedding is coming up.

In Article 14 of our Collective Agreement, you will see that Regular staff are allotted vacation leave depending on their years of service. The amount shown is the hours earned for Full Time employees. Part Time workers are prorated by the number of regular hours on the schedule they work each week.

For example Article 14.3 tells us that in the second and up to seventh year, full time employees have 105 hours or 3 weeks. A part time worker who has 21 hours each week on the schedule will have 63 hours of vacation leave for the current year.

Each Branch Manager, with the assistance of the

Circulation Supervisor, may create mock schedules to determine the amount of staff coverage required and pairs that against all requests submitted for the branch staff. They will also consider seniority to approve or deny requests before submitting total number of Casual staff required to fill in the gaps. Peak periods for vacation requests are the last two weeks in June to first week in Sept, as well as the 2 weeks around Christmas.

If you are planning a trip, don't make any reservations or buy any plane tickets before your requests are approved. It might be at a loss if you need to reschedule your trip if your requests are denied.

If you are requesting time for a special occasion like a family reunion or wedding, be sure to add that in the comment field of your request.

Talk to your coworkers about vacation requests as its sometimes better to coordinate with them so there isn't too many people trying to request the same block of time so hopefully no one will be denied.

We have been allowed to take our vacation in hours, or days or weeks so there are many options to use your time off.

Be sure to check the expiry date if you have Supplementary Vacation. After 10 years of service, we receive an additional 35 hours to use over a 5 year period. If you forget, they may be taken out of your bank.

If you have questions regarding your vacation leave, ask any Executive member or your supervisor to explain the details to you.

Help support locked out CUPE 7000 workers



CUPE Local 7000 members were locked out by their employer (Southern Railway) at 5:00 am January 5, 2015. CUPE Local 7000 represents 126 rail yard employees. Local 7000 have been trying to negotiate a fair and respectful agreement;

however, the employer is demanding significant concessions. Southern Railway has 29 locomotives and 700 railcars and is part of the Washington Companies which include Seaspan Corporation. The railway is the major freight transporter in the Lower Mainland and Fraser Valley, with almost half the traffic originating or terminating at Annacis Island.

Since the lockout, the trains have been operated by approximately 20 of the company's 34 managers. There is video footage of a train rolling through a crossing on Annacis Island with no headlights or front ditchlights on. CUPE 7000 has reported other incidents to the Safety Authority since the lockout began. This proves that Southern Railway needs to park the trains and get back to the bargaining table.

CUPE BC is encouraging locals to provide support if possible at the following picket lines:

This employer operates on a 24/7 basis so support on the picket lines would be appreciated anytime day or night.

Hearty Short Rib Stew

Ingredients:

- 3-4 lbs short ribs, cut each piece in half
- 1/2 cup flour
- 1 tsp smoked paprika
- 1 tsp black pepper
- 1 large sweet onion, chopped and divided in 2 portions
- 2 stalks celery, chopped
- 1 large can diced tomatoes
- 2 cups dry red wine
- 4 bay leaves
- 15 peppercorns
- sprig of rosemary
- 5 cloves of garlic
- enclose herbs in a large tea ball or tie in a piece of cheese cloth
- 4 med yukon gold potatoes
- 4 med carrots
- 3 parsnips
- 1 med rutabaga
- 1 litre beef broth
- small basket of cherry tomatoes
- salt, pepper

Directions:

Combine flour, pepper and paprika. Dredge pieces of short ribs. Save flour for thickening later. In skillet, heat oil (of choice), brown meat on all sides and transfer to large pot. Once all the meat is done, sauté 1/2 chopped onion and transfer to pot. Deglaze pan with red wine. Scraping all bits off pan, add to pot. Add tomatoes and herbs. Bring to a boil, reduce to med-low heat and simmer for 2 hours. Stir occasionally.

Wash and prepare vegetables. Cut into 1 inch cubes. Remove bones when simmering time is done. cut meat into smaller pieces if desired. Add vegetables and enough broth for cooking. Bring up to boil again, reduce heat and simmer for 45 minutes or until all veg is tender. Stir occasionally. Add cherry tomatoes. Increase to med heat. In a separate cup, whisk remaining flour with 1 cup of hot broth (from pot) then stir into pot to thicken stew. Add salt and pepper if desired.

Serve with thick slices of sourdough bread. Enjoy.
